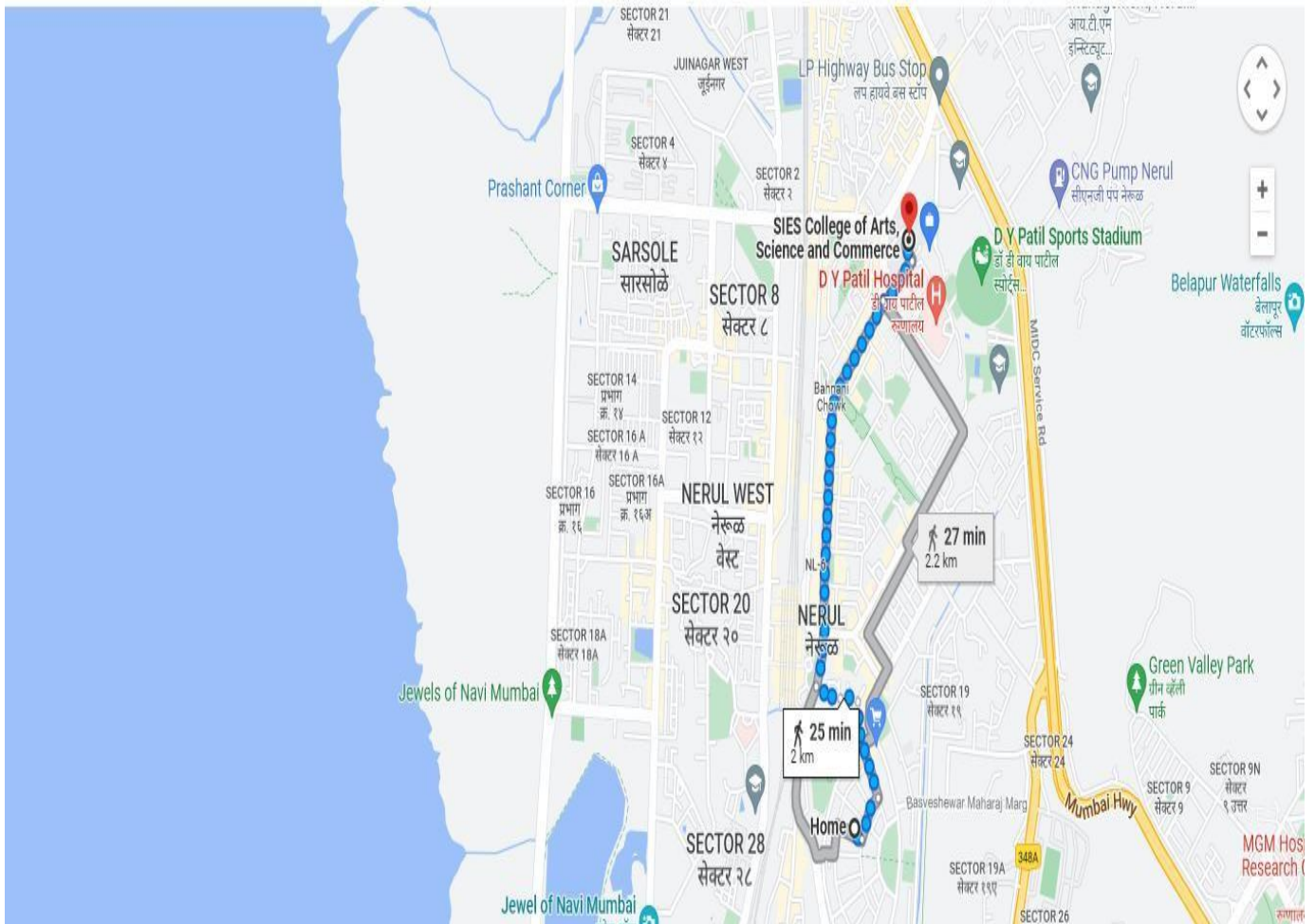

PROFILE OF THE COLLEGE

The Society strives towards excellence in all its pursuits and believes in strict discipline.

The SIES (NERUL) COLLEGE OF ARTS, SCIENCE & COMMERCE, (SIESASCN) was established in September 1998, as a Commerce College and is affiliated to the University of Mumbai. The College is entering its Twenty-Five year in September 2023 and has been attracting students from far and near. The College added Science (Computer Science, Information Technology and Environmental Science) and Arts faculty (Mass Media) in the year 2001 and 2002 respectively and was renamed as SIES (Nerul) College of Arts, Science and Commerce. The College has a Junior College of Commerce attached to it. The College has been growing steadily by introducing new courses as per the demands of the society. Presently, the College has Junior College of Commerce, 8 undergraduate and 4 postgraduate courses in Arts, Science & Commerce.

The College is approved by UGC under 2f and 12 (B) and has been Reaccredited with 'A' grade by the NAAC in the 3rd cycle in the year 2021. The culture at SIESASCN is to continuously reset standards to a higher level to ensure increased productivity. The College is proud of its alumni who have excelled in diverse fields. By creating the right synergy between all the stakeholders, the College aspires to scale greater heights in the years to come.

The vision of the College is to see that the students become either entrepreneurs or employable in the competitive world. The differently abled, underprivileged are all given equal status. There is an active Placement Committee in place. As a part of the Institutional Social Responsibility, there are different Committees like the NSS Unit, the Student Council, Gender Sensitisation Cell and Conservation Club which work towards inculcating social values and concern for environment in the students.

COLLEGE INFRASTRUCTURE

SIES (Nerul) College of Arts, Science and Commerce provides infrastructure to facilitate the education process and enhance the learning ability of the students. It aims at developing intellectual capabilities and an understanding of the relationship between education and the real world. The Institute has adequate infrastructure to accommodate curricular, co- curricular and extracurricular activities.

The college uses state of art technology in its teaching process making use of collar mikes, cordless mikes and smart boards. Every department is assigned with a laptop and every classroom has dedicated desktops connected to projector.

Physical Infrastructure:

1. Classrooms:

The Institute has 29 classrooms which are well ventilated with adequate seating arrangements as well LAN connections. The classrooms are well equipped with teaching aids such as LCD projectors and Smart board with internet facility. Seven classrooms are smart class rooms with virtual class room facilities.

2. Gymkhana:

The spirit of sportsmanship is encouraged by the college. A spacious common Gymkhana for girls and

boys is well equipped with indoor facilities like chess board, Carom, Table Tennis Table, Tread-mill, Bench Press, elliptical cycle, punching bag for work out.

3. Auditoriums and Halls:

The talent of the students is given a supportive platform through the auditoriums, seminar hall and conference rooms at SIES Nerul Campus.

4. **Laboratories:** The Institute has 10 laboratories. Amongst the 10 laboratories seven are computer laboratories, one is media laboratory, one is environmental science laboratory and one is electronic laboratory. The Institute has 258 computers with antivirus software including 4 servers. Computer Laboratories are well equipped to conduct practical sessions in batches for undergraduate and post graduate students. The Institute has one dedicated media laboratory with internet facility for Department of Multimedia and Mass Communication.

5. **Library:** The Institute has a spacious Library which is fully air-conditioned covering **3507.44 sq. ft.** area with an adequate seating capacity for under graduate and post graduate students. There is also special seating arrangement for physically challenged learners and staff members in the faculty area of the library. There are two reading rooms to inculcate reading practice. The library is connected to the internet by LAN and Wi-Fi. It houses hard and soft copy of books of all genres and facilitates promotion of teaching, learning and research.

A study center which consists of 8 computers with internet access and a Reprographic facility for faculties and students is available in the library.

Issue / Return Policy of Library

Books / magazines to be issued for a period of 7 days – as per library timetable only

Fine = Rs. 5 per day of default

The issue / return system being computerized, books once issued will not be accepted back on the same day

Issue / return of books will not be done against the library cards of other students

Reissue of books will be done only if there is no demand for that particular book. Reissue of any book may be done two times only. Students must sign the book card at the time of issuing books

CDs – to be issued only on Wednesdays for a period of 7 days

6. **Examination Room:** The College has a fully functional examination room where the entire examination work is carried out in a very confidential manner.

7. **Hygienic rest rooms** for boys and girls are available on each floor. A separate ladies common room and Gents Common Room is there for Ladies and Gents to relax in case of any health issue.

8. **Facilities for Sports:** There is a sprawling campus of 6.5 acres with adequate open space giving ample opportunity for outdoor activities. The Institute has a dedicated and experienced Sports Coordinator who looks after the sports related activities on the campus. There is a **Gymkhana** of 833.25 sq. ft. area to conduct indoor games. Institute has adequate sports equipment for indoor and

outdoor games. The institute has established Yogsadhanakendra with a capacity of 50. The yoga instructor trains as well as oversees yoga sessions for students and staff.

9. Canteen: The College has an excellent Canteen Facility to facilitate hygienic and nutritious food at reasonably priced merchandise and services essential to students comfort and well-being.

10. Special facilities for Divyangjan: Institute have paid attention to provide Divyangjan friendly environment and provides with facilities such as Special arrangements in Washrooms, Ramp, Lift, wheelchair and separate Parking space. Software named OpenBook Reader combined with PEARL scanner is installed in the library for blind and lowvision students enabling them to read

11. Security: Safety norms are strictly adhered to in the Institute in all aspects. There are 5 professional security personnel for the Institute. The campus is under the surveillance of 44 CCTVs installed at strategic locations to ensure the security of students and all stake holders. Fire extinguishers are located at strategic locations over the entire campus.

12. Counselor: A Health cum counseling center has been operational for many years. A qualified counselor visits the college three days a week. The students and staff consult the counselor in times of emergency.

13. First Aid Facility: College has first aid facility room equipped with first aid medicine and in case of emergency college has wheel chair, stretcher and walker to move injured person to Suyash hospital or DY Patil Hospital.

The College is now expanding with its infrastructure facility with respect to the classrooms in the 5th floor.

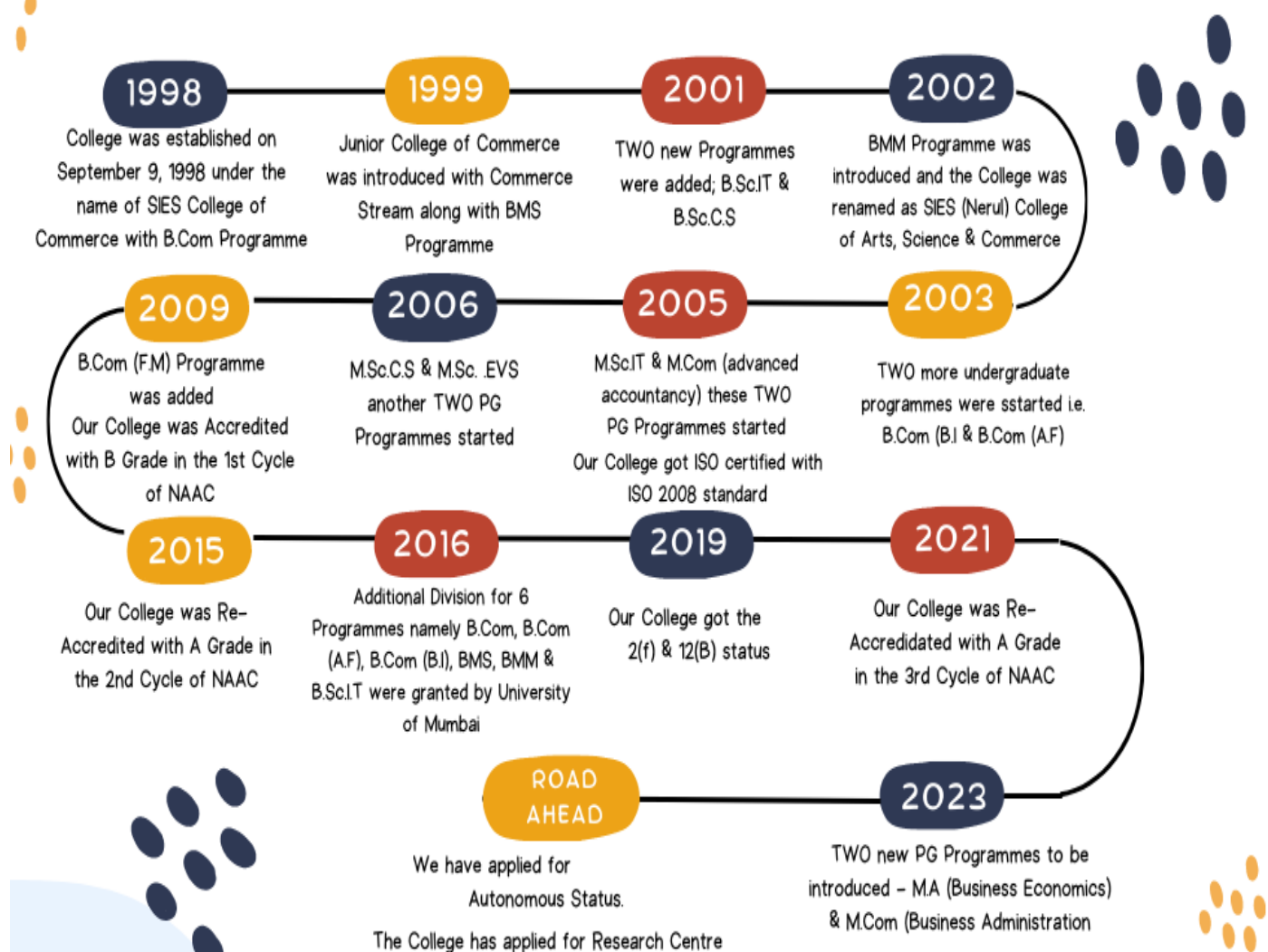

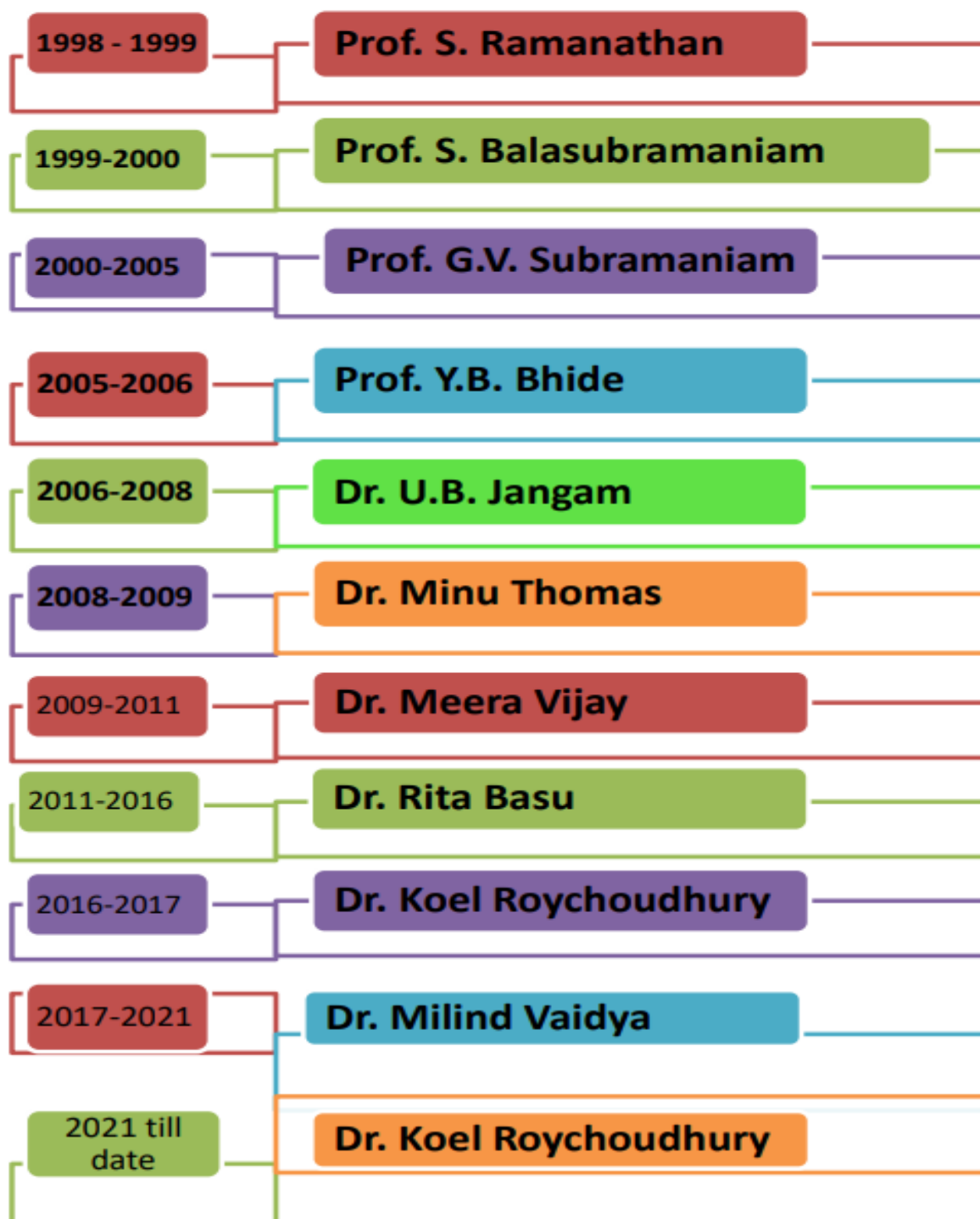

RULE CONCERNING ADMISSION TO JUNIOR COLLEGE

1. A student who has passed FYJC Examination will be eligible for admission to the SYJC class.
2. A student of any other college affiliated to Maharashtra Board seeking admission to SYJC class (Subject to seat availability) will have to submit NOC from the respective college in addition to the above mentioned documents.
3. Repeater will not be admitted.
4. A student who has passed the SSC Examination conducted by the Maharashtra State Board of Secondary and Higher Secondary Education, in the subjects of English, Mathematics, Social Science, Science and other languages carrying 200 marks or an examination recognized equivalent thereto will be eligible for admission to FYJC class. Admission to FYJC starts after declaration of the SSC Examination results of the Maharashtra Board.
5. For admission to it is necessary to produce in original the following:
 - A. The passing certificate of the last examination passed.
 - B. Statement of Marks.
 - C. Leaving Certificate.
 - D. LC or Transfer Certificate in the case of students coming from other Boards.
 - E. Eligibility Certificate in the case of students passing an examination other than SSC Examination of the Maharashtra State Board of Education or an examination of any Board.
 - F. Migration Certificate in the case of students coming from other Boards.
6. Admissions are provisional until Final Eligibility Certificate / Transfer Certificate / Migration Certificate is obtained from the HSC Board to the College.

Step (c) be repeated for the subsequent merit lists till all the forms are exhausted or the final merit list is displayed, whichever is earlier.

- e) A learner shall be allowed to keep term for Semester VI irrespective of number of courses of failure in the Semester V.
- f) The learner can appear for the Semester VI Examination (subject to d & e) above) but the result of Semester VI shall be kept in abeyance until the learner passes each of Semester I, Semester II, Semester III & Semester IV and Semester V.

For all Science Programmes Carrying total 900 or more marks

A learner shall be allowed to keep term for Semester V if he /she passes Semester I, Semester II and Semester IV

He/ She has passed Semester I and Semester II and fails in not more than three courses with not more than 200 marks in each semester III and Semester IV (For all Science Programs carrying less than Total 900 marks)

Passing Standard

6. All admissions are valid only for one academic year and are required to be renewed by application in the prescribed form for every subsequent year of study in the College.
7. A student once, admitted will be considered as duly enrolled for the academic year unless he/ she informs the Principal, in writing of his intention to leave the College.
8. Fees shall be paid only through online mode
9. In case of revision of fees during the year, the students shall be required to pay the difference in fees.

GUIDELINES FOR CANCELLATION OF ADMISSION AND REFUND OF FEES

Ordinance 2859: Refund of Tuition, Development and all other fees after cancellation of admissions:

Ordinance - 0.6086 Relating to Attendance for granting the terms in each subject, a **minimum attendance of 75% of the average of the total number of theory lectures, practical and tutorials (wherever prescribed), and a 50% attendance for each subject will be required out of the total number of lectures, practical and tutorials in the subject conducted during the term/semester.**

A student who is not able to attend his/her classes regularly and/or who is not able to complete his/her tutorial/project/assignments properly may not be permitted to appear for the examinations as per the University rules.

Ordinance - 0.6086 relating to the keeping of terms to the satisfaction of the Principal of the College:- To keep a term at a college or recognised institution, an undergraduate or post graduate student must complete, to the satisfaction of the Principal or the Head of the Institution, the course of study at the college or institution, prescribed for such a term for the class to which such an undergraduate or post graduate student belongs.

If students are not able to attend lectures and/or tutorials for a period exceeding a week in a term, they should take prior permission from the College Principal, for such absence.

The same ratio shall be applied for computing the attendance of the learners by crediting the number of periods which are missed while participating in an extracurricular/co-curricular activity/competition/camp/ workshop/ convention/symposium/seminar etc. where the said learner is officially representing the College/ University/ District / State/ Country with the permission of the Principal /Director/ Head of the College/ Institute/ University Department or by the direction of the University Officer as the case may be wherein for the purpose of computing the average attendance the periods missed for what is envisaged here-in-above, at Sr. no 2, shall be deemed to have been attended by the said learner .

Leave of Absence: In case students are not able to attend lectures and / or tutorials for a period exceeding a week in a term, they should give intimation to the Principal of the College and take prior permission for such absence.

Absence on medical or other grounds: Absence on medical or other grounds, which is given to the satisfaction of the Principal, may be considered a satisfactory reason for absence from lectures or tutorials. Yet at the time of granting the terms to a student, his/her class work and other academic inputs would be considered to be of paramount importance. Hence, a student may not be granted his / her terms even if

he/she explains his/her absence on medical or other grounds. Absence should be with prior permission; in case it is due to unforeseen circumstances an application duly supported by other satisfactory evidence in the case of other reasons, must reach the Principal within a week of such occasion of absence.

DRESS CODE

Students are expected to wear decent clothes. Students are strictly prohibited from wearing the following while on the college premises:

BOYS: Caps, Hats, Half-pants, Shorts, Bermuda, Sleeveless T-shirts and 3/4th pants, Ripped Jeans, Torn Jeans.

GIRLS: Caps, Hats, Half-pants, Shorts, Bermuda, Skin tight dresses, revealing dresses, Short dresses or short skirts, Sleeveless and short tops, Ripped Jeans, Torn Jeans, and pedal pushers. Facial piercing other than earrings and nose rings strictly prohibited. Any other attire which according to the College authorities is not suitable to the College culture / environment will not be permitted.

CELLPHONES

Use of cell phones in any form in the classrooms and corridors is strictly prohibited. On breach of this discipline, the cellphone holder will be liable for a penalty of Rs. 1000/- for the first offence. In case of a repetition of the offence the cellphone shall be liable to be confiscated.

Cell Phones are strictly not allowed in the Examination Halls.

Students are required to take adequate care of their belongings while on the College premises. Management will not be responsible for any theft /damage to the belongings.

IDENTITY CARD

IDENTITY CARD A valid identity card is issued to every bonafide student at the time of admission. It is compulsory for every student to carry the identity card while being on the campus. Students will not be allowed in the examination hall without a valid identity card. For University examinations, candidates are required to produce their identity cards bearing their photographs attested by the Principal, along with their hall tickets at the examination centers. It is a serious offence to carry and use another student's identity card and shall be punished if discovered.

RAILWAY CONCESSION

Students can avail concessional fares for rail travel by local trains between the stations nearest to the place of their residence in Mumbai / Navi Mumbai/ Thane and the college (Nerul). Students are requested to enter their local and permanent addresses correctly in the admission forms to facilitate issue of railway concession orders. The place of permanent residence, in the application for admission, means the place where the student and/or his parents normally reside. This address will not be allowed to be changed during the academic year. Students can also avail, during vacation period, concessional fares by rail for journeys between their place of permanent residence and Mumbai / Navi Mumbai/ Thane during vacation.

OTHER GENERAL INSTRUCTIONS

1. Students are expected to read the Notice Boards DAILY for academic and administrative information.
2. The working hours of the office are **10.30 am to 1pm**. The Visiting hours for the Principal's office is between **10.30 am and 1pm**.
3. Application for any certificate and railway concession should be submitted to the office three days in advance.
4. Grievances of students will be addressed through the Grievance Redressal Cell.

NOTICE

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the University Grants Commission has framed UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" which have been notified on 4th July, 2009 in the Gazette of India. These regulations are mandatory for all Universities/Institutions. The UGC has made it mandatory for all students / parents to submit anti ragging related affidavits to the institutions at the time of admission. Now it is brought to the notice of all Universities, Institutions, Students and Parents that these affidavits can be downloaded from the website of UGS and or other related websites.

ANTI RAGGING WARNING

- (1) Ragging is cognizable offence under the law on par with rape and other atrocities against women and ill-treatment towards persons belonging to SC/ST. Ragging is strictly prohibited in the entire institution, including its department, constituent units, all its premises (including academic, residential, sports, canteen or outside).
- (2) Students indulging in ragging other students will be punished as per "The Maharashtra Prohibition of Ragging Act 1999 (Mah. XXXIII of 1999) published by Maharashtra Govt. Gazette on 15th May 1999". In pursuance to the judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the University Grants Commission has framed "UGC Regulations on curbing the menace of ragging in higher educational institutions, 2009" which have been notified on 4th July 2009 in the Gazette of India".
- (3) Administrative actions in the event of Ragging : The Institution shall punish student/s found guilty of ragging after following the procedure and the manner prescribed herein under:
 - a. The Anti-Ragging committee of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging, and nature and gravity of the incident of ragging, established in the recommendation of the Anti-Ragging Squad.
 - b. The Anti-Ragging committee may, depending upon the nature and gravity of the guilt established by the Anti-Ragging Squad award to those found guilty, one or more of the following punishments, namely:
 - i. Suspension from attending classes and academic privileges.
 - ii. Withholding / withdrawing scholarship/ fellowship and other benefits.
 - iii. Debaring from appearing in any test / examination or other evaluation process.
 - iv. Withholding results.
 - v. Debaring from representing the institution in any regional/national or international meet, tournament, youth festival etc.

- vi. Cancellation if admission.
- vii. Rustication from the Institution for period ranging from one to four semester.
- viii. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period. Provided that where the person committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.

Prohibition on sale of Cigarettes or Tobacco Products

Section 6 of the Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce. Production, Supply and Distribution) Act 2003 provides that no person shall sell, offer for sale or permit sale of Cigarettes or any other Tobacco Product.

- a) To any person who is under eighteen years of age
- b) In an area within a radius of 100 yards of any educational Institute.

Sale of Cigarette and other Tobacco Products in an area within a radius of 100 yards of an educational institute is strictly prohibited and is punishable offence under Section 24 of the Act with a fine which may extend up to 200 Rupees.

STUDENTS HELP CENTRE:

Bridge Course: A 10 hour Bridge Course in the subject of Accounting, Mathematics, English and Economics is conducted at the beginning of the academic year. The course is designed by the Result Improvement Committee.

Mentor System: The College designates a faculty member as mentor for a group of 30-40 students. The mentor meets the students once a month, in a group and interacts with them about their academic and personal difficulties and helps to sort them out. A student can access his/her mentor any time when there is a difficulty.

Counseling Centre: Students are counseled by Expert psychologists about their grievances and issues. The discussions are kept confidential. The students are suggested various therapies to handle their difficulties. The institute also has a counseling committee which organizes various activities for spreading awareness on mental well-being of students and staff.

Grievance Redressal: The cell is intended to find solutions for grievances like physical or mental harassment, complaints regarding class room teaching, class room management, completion of syllabus, teaching methodology, infrastructure maintenance and up gradation, etc. if and when they arise.

Internal Compliance Committee: Our College has an active ICC Cell to prevent discrimination and sexual harassment against girls by promoting gender amity among students and employees.

Equal Opportunity Cell: The Equal Opportunity Cell was established in the year 2022-23 , to aid and advise the students belonging to marginalized sections including the Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Communities (OBCs), minority communities, etc. pursuing various programs of studies at the College.

Hostel Facility

Volunteers from Eight different streams (B.Com, BMS, BMM, B.Com (AF), B.Com (BI), B.Com (FM) , B.Sc. IT, B.Sc. CS are involved. NSS Units Conducts Various Activities which includes Tree Plantation, Blood Donation, Rallies & Street Play, Cleanliness Drive (Swatch Bharat Abhiyan), Disaster Management Training, Celebration of Festivals and National / International Days, Health & Safety Awareness Campaigns, 7 days Residential Camp. Students who complete 120 hours of social work are entitled to be awarded 10 grace marks in their first appearance at the examination as laid down under ordinance 229.

It is the Alumni Association duly registered and recognized by the SIES (NERUL) College of Arts, Science and Commerce. 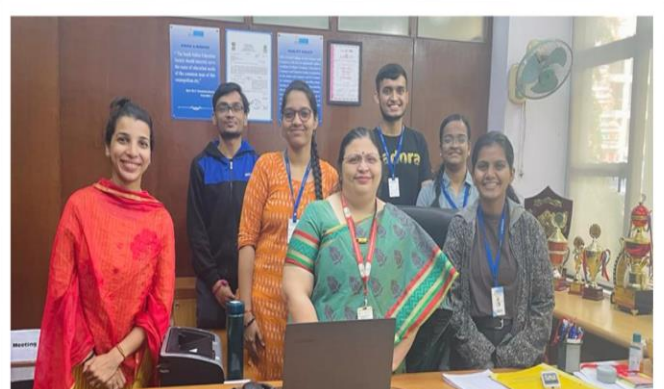
