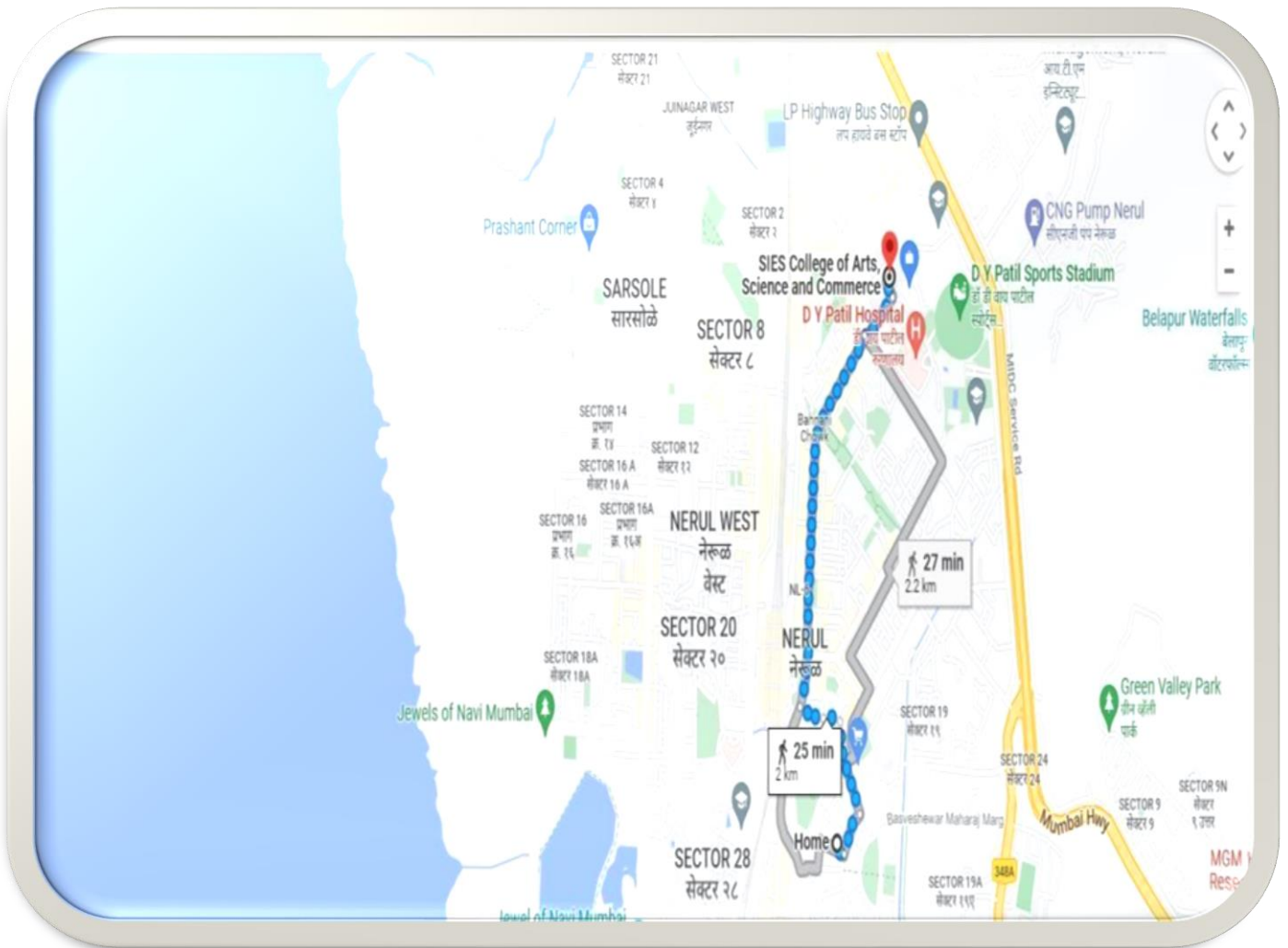

## PROFILE OF THE COLLEGE

**The SIES (NERUL) COLLEGE OF ARTS, SCIENCE & COMMERCE, (Autonomous) was established in September 1998, as a Commerce College and is affiliated to the University of Mumbai.** The College is entering its 26 year in September 2024 and has been attracting students from far and near. The College added Science (Computer Science, Information Technology and Environmental Science) and Arts faculty (Mass Media) in the year 2001 and 2002 respectively and was renamed as SIES (Nerul) College of Arts, Science and Commerce. Presently, the College has Junior College of Commerce **and will be running 13 Undergraduate and 7 Postgraduate courses in Arts, Science & Commerce.**

## COLLEGE INFRASTRUCTURE

**SIES (Nerul) College of Arts, Science and Commerce (Autonomous)** provides infrastructure to facilitate the education process and enhance the learning ability of the students. It aims at developing intellectual capabilities and an understanding of the relationship between education and the real world. The Institute has adequate infrastructure to accommodate curricular, co- curricular and extracurricular activities.

The college uses state of art technology in its teaching process making use of collar mikes, cordlessmikes and smart boards. Every department is assigned with a laptop and every classroom has dedicated desktops connected to projector.

### **Physical Infrastructure:**

#### **1. Classrooms:**

The Institute has 38 classrooms with the new expansion in its infrastructure facility with respect to the classrooms in the 5<sup>th</sup> floor. All the rooms are well ventilated with adequate seating arrangements as well LAN connections. The classrooms are well equipped with teaching aids such as LCD projectors and Smart board with internet facility. Seven classrooms are smart class rooms with virtual class room facilities.

#### **2. Gymkhana:**

The spirit of sportsmanship is encouraged by the college. A spacious common Gymkhana for girls and boys is well equipped with indoor facilities like chess board, Carom, Table Tennis Table, Tread-mill, Bench Press, elliptical cycle, punching bag for work out.

#### **3. Auditoriums and Halls:**

The talent of the students is given a supportive platform through the auditoriums, seminar hall and conference rooms at SIES Nerul Campus.

4. **Laboratories:** The Institute has 9 laboratories. Amongst the 9 laboratories 7 are computer laboratories, 01 is Media Laboratory and 01 is Environmental Science laboratory. The Institute has 258 computers with antivirus software including 4 servers. Computer Laboratories are well equipped to conduct practical sessions in batches for undergraduate and post graduate students. The Institute has one dedicated media laboratory with internet facility for Department of Multimedia and Mass Communication.

5. **Library:** The Institute has a spacious Library which is fully air-conditioned covering **3507.44 sq. ft.** area with an adequate seating capacity for under graduate and post graduate students. Library is automated using Integrated Library Management System (ILMS). Library has 25303 books, 12002 reference titles. N list e journals package programme is subscribed.. The

library is spacious and air conditioned with a seating capacity of 150 students. Separate room is provided for faculty members. There is also a separate research space in the library where students are provided with computers to access information.

There is also special seating arrangement for physically challenged learners and these students are profited from SPARSH software in the library. The library is connected to the internet by LAN and Wi- Fi. It houses hard and softcopy of books of all genres and facilitates promotion of teaching, learning and research.

**A study center** which consists of 8 computers with internet access and a Reprographic facility for faculties and students is available in the library.

### **Issue / Return Policy of Library**

Books / magazines to be issued for a period of 7 days – as per library timetable only

Fine = Rs. 5 per day of default

The issue / return system being computerized, books once issued will not be accepted back on the same day Issue / return of books will not be done against the library cards of other students

Reissue of books will be done only if there is no demand for that particular book. Reissue of any book maybe done two times only. Students must sign the book card at the time of issuing books

6. **Examination Room:** The College has a fully functional examination room where the entire examination work is carried out in a very confidential manner.

7. **Hygienic rest rooms** for boys and girls are available on each floor. A separate girl's common room and boy's common room are there where they can relax in case of any health issues.

8. **for Sports:** There is a sprawling campus of 6.5 acres with adequate open space.

9. **Facilities for sports:** There is a sprawling campus of 6.5 acres with adequate open space giving ample opportunity for outdoor activities. The Institute has a dedicated and experienced Sports Coordinator who looks after the sports related activities on the campus. There is a Gymkhana of 833.25 sq. ft. area to conduct indoor games. Institute has adequate sports equipment for indoor and outdoor games.

10. **Canteen:** The College has an excellent Canteen Facility to facilitate hygienic and nutritious food at reasonably priced merchandise and services essential to students comfort and well-being.

11. **Special facilities for Divyangjan:** Institute has paid attention to provide Divyangjan friendly environment and provides with facilities such as Special arrangements in Washrooms, Ramp, Lift, wheelchair and separate Parking space. Software named Open Book Reader combined with PEARL scanner is installed in the library for blind and low vision students enabling them to read

12. **Security:** Safety norms are strictly adhered to in the Institute in all aspects. There are 5 professional **security** personnel for the Institute. The campus is under the surveillance of 44 CCTVs installed at strategic locations to ensure the security of students and all stake holders. Fire extinguishers are located at strategic locations over the entire campus.

13. **Counselor:** A Health cum counseling center has been operational for many years. A qualified counselor visits the college three days a week. The students and staff consult the counselor in times of emergency.

14. **First Aid Facility:** College has first aid facility room equipped with first aid medicine and in case of emergency college has wheel chair, stretcher and walker to move injured person to Suyash hospital or DY Patil Hospital.

The Student must produce testimonials from at least two teachers who have personally taught the student in school / College stating why the teachers feel that the student should do the course and how the course will benefit the student. The testimonials may not exceed 150 words each. The testimonial must mention the period that the teacher has been associated with the student, in which institution and how long has the teacher been with the said institution. The testimonials must accompany the admission form. The testimonials may be written in English, Hindi or Marathi.

The Department of Communication and Journalism shall conduct a test comprising of a written examination of 100 marks, a group discussion of 100 marks and a personal interview of 100 marks. Candidates, who have passed their Bachelor 's Degree in any faculty from the University of Mumbai or any other University recognised by the University of Mumbai and those who have submitted the application forms of the Department of Communication and Journalism along with the statement of purpose and the two testimonials mentioned above, shall be eligible to appear for this examination.

## IMPORTANT RULES AND REGULATIONS

### COLLEGE DISCIPLINARY RULES

**Parents/Guardians/Students are requested to read and acquaint themselves with the below mentioned rules of conduct and discipline. Students must ensure strict compliance with these rules.**

Students are required to take adequate care of their belongings while on the College premises. Management will not be responsible for any theft /damage to the belongings.

In the College premises, every bonafide student at the College must wear the **Identity Card**.

A student found in a class/ tutorial batch or a division or a class, which is not meant for him/her, will be liable for punishment.

Students should not loiter in the corridors or in the College premises particularly when classes are in session.

A student should not invite any outsider to the College premises, classrooms, library, canteen or gymkhana.

**No fund-raising activity** should be undertaken by any student without prior written permission from the Principal.

Students are not permitted to park two wheelers or four wheelers in the College premises without valid License and Helmet. Our Campus is **No Helmet No Entry**

Students should take care of, and not cause any damage to, the College property.

The Principal has the power to determine suitable disciplinary action in case of indiscipline and improper conduct of the students while in the college.

If for any reason, in the opinion of the Principal, the continuance of any student in the College is deemed detrimental to the interest of the College.

Absence should be with prior permission; in case it is due to unforeseen circumstances, an application duly supported by a medical certificate in the case of illness or duly supported by other satisfactory evidence in the case of other reasons, must reach the Principal within a week of such occasion of absence.

Admission to Second Year and Third Year classes will be granted on the basis of attendance and academic performance.

Students with poor academic performance and conduct may not be admitted to the next semester/subsequent year as the case may be, and the admission of such students shall be solely at the discretion of the Principal.

Students are warned that they **should not indulge in any form of ragging**. Any student found involved or abetting in ragging, will be dealt with as **per provisions of law**.

## ATTENDANCE

**Ordinance - 0.6086** Relating to Attendance for granting the terms in each subject, a **minimum attendance of 75% of the average of the total number of theory lectures, practical and tutorials (wherever prescribed), and a 50% attendance for each subject will be required out of the total number of lectures, practical and tutorials in the subject conducted during the term/semester.**

A student who is not able to attend his/her classes regularly and/or who is not able to complete his/her tutorial/project/assignments properly may not be permitted to appear for the examinations as per the University rules.

**Ordinance - 0.6086** relating to the keeping of terms to the satisfaction of the Principal of the College:- To keep a term at a college or recognised institution, an undergraduate or post graduate student must complete, to the satisfaction of the Principal or the Head of the Institution, the course of study at the college or institution, prescribed for such a term for the class to which such an undergraduate or post graduate student belongs.

If students are not able to attend lectures and/or tutorials for a period exceeding a week in a term, they should take prior permission from the College Principal, for such absence.

The same ratio shall be applied for computing the attendance of the learners by crediting the number of periods which are missed while participating in an extracurricular/co-curricular activity/competition/camp/ workshop/ convention/symposium/seminar etc. where the said learner is officially representing the College/ University/ District / State/ Country with the permission of the Principal /Director/ Head of the College/ Institute/ University Department or by the direction of the University Officer as the case may be wherein for the purpose of computing the average attendance the periods missed for what is envisaged here-in-above, at Sr. no 2, shall be deemed to have been attended by the said learner .

**Leave of Absence:** In case students are not able to attend lectures and / or tutorials for a period exceeding a week in a term, they should give intimation to the Principal of the College and take prior permission for such absence.

**Absence on medical or other grounds:** Absence on medical or other grounds, which is given to the satisfaction of the Principal, may be considered a satisfactory reason for absence from lectures or tutorials. Yet at the time of granting the terms to a student, his/her class work and other academic inputs would be considered to be of paramount importance. Hence, a student may not be granted his / her terms even if

he/she explains his/her absence on medical or other grounds. Absence should be with prior permission; in case it is due to unforeseen circumstances an application duly supported by other satisfactory evidence in the case of other reasons, must reach the Principal within a week of such occasion of absence.

## DRESS CODE

Students are expected to wear decent clothes. Students are strictly prohibited from wearing the following while on the college premises:

**BOYS:** Caps, Hats, Half-pants, Shorts, Bermuda, Sleeveless T-shirts and 3/4th pants, Ripped Jeans, Torn Jeans.

**GIRLS:** Caps, Hats, Half-pants, Shorts, Bermuda, Skin tight dresses, revealing dresses, Short dresses or short skirts, Sleeveless and short tops, Ripped Jeans, Torn Jeans, and pedal pushers. Facial piercing other than earrings and nose rings strictly prohibited. Any other attire which according to the College authorities is not suitable to the College culture / environment will not be permitted.

### **CELLPHONES**

Use of cell phones in any form in the classrooms and corridors is strictly prohibited. On breach of this discipline, the cellphone holder will be liable for a penalty of Rs. 1000/- for the first offence. In case of a repetition of the offence the cellphone shall be liable to be confiscated.

Cell Phones are strictly not allowed in the Examination Halls.

### **IDENTITY CARD**

**IDENTITY CARD** A valid identity card is issued to every bonafide student at the time of admission. It is compulsory for every student to carry the identity card while being on the campus. Students will not be allowed in the examination hall without a valid identity card. For University examinations, candidates are required to produce their identity cards bearing their photographs attested by the Principal, along with their hall tickets at the examination centers. It is a serious offence to carry and use another student's identity card and shall be punished if discovered.

### **RAILWAY CONCESSION**

Students can avail concessional fares for rail travel by local trains between the stations nearest to the place of their residence in Mumbai / Navi Mumbai/ Thane and the college (Nerul). Students are requested to enter their local and permanent addresses correctly in the admission forms to facilitate issue of railway concession orders. The place of permanent residence, in the application for admission, means the place where the student and/or his parents normally reside. This address will not be allowed to be changed during the academic year. Students can also avail, during vacation period, concessional fares by rail for journeys between their place of permanent residence and Mumbai / Navi Mumbai/ Thane during vacation.

### NOTICE

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the University Grants Commission has framed UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" which have been notified on 4th July, 2009 in the Gazette of India. These regulations are mandatory for all Universities/Institutions. The UGC has made it mandatory for all students / parents to submit anti ragging related affidavits to the institutions at the time of admission. Now it is brought to the notice of all Universities, Institutions, Students and Parents that these affidavits can be downloaded from the website of UGS and or other related websites.

### ANTI RAGGING WARNING

- (1) Ragging is cognizable offence under the law on par with rape and other atrocities against women and ill-treatment towards persons belonging to SC/ST. Ragging is strictly prohibited in the entire institution, including its department, constituent units, all its premises (including academic, residential, sports, canteen or outside).
- (2) Students indulging in ragging other students will be punished as per "The Maharashtra Prohibition of Ragging Act 1999 (Mah. XXXIII of 1999) published by Maharashtra Govt. Gazette on 15<sup>th</sup> May 1999". In pursuance to the judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the University Grants Commission has framed "UGC Regulations on curbing the menace of ragging in higher educational institutions, 2009" which have been notified on 4<sup>th</sup> July 2009 in the Gazette of India".
- (3) Administrative actions in the event of Ragging : The Institution shall punish student/s found guilty of ragging after following the procedure and the manner prescribed herein under:
  - a. The Anti-Ragging committee of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging, and nature and gravity of the incident of ragging, established in the recommendation of the Anti-Ragging Squad.
  - b. The Anti-Ragging committee may, depending upon the nature and gravity of the guilt established by the Anti-Ragging Squad award to those found guilty, one or more of the following punishments, namely:
    - i. Suspension from attending classes and academic privileges.
    - ii. Withholding / withdrawing scholarship/ fellowship and other benefits.
    - iii. Debarring from appearing in any test / examination or other evaluation process.
    - iv. Withholding results.
    - v. Debarring from representing the institution in any regional/national or international meet, tournament, youth festival etc.

- vi. Cancellation if admission.
- vii. Rustication from the Institution for period ranging from one to four semesters.
- viii. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period. Provided that where the person committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.

### **Prohibition on sale of Cigarettes or Tobacco Products**

Section 6 of the Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce. Production, Supply and Distribution) Act 2003 provides that no person shall sell, offer for sale or permit sale of Cigarettes or any other Tobacco Product.

- a) To any person who is under eighteen years of age
- b) In an area within a radius of 100 yards of any educational Institute.

Sale of Cigarette and other Tobacco Products in an area within a radius of 100 yards of an educational institute is strictly prohibited and is punishable offence under Section 24 of the Act with a fine which may extend up to 200 Rupees.

### **STUDENTS HELP CENTRE:**

**Bridge Course:** Bridge course is an initiative that enables to bridge the gap between the academically weak and strong students by solving subject specific problems of the former. Students are classified as slow and advanced learners based on their performance in the lower exams and class tests. The College organizes Bridge Course in subjects like Accountancy, Mathematics and English.

Remedial lectures and assignments are given for slow learners. The advanced learners are encouraged with the title 'ALTA PERFORMERS' and participate in power point presentations, case study discussions, PG tutorship and field visits and are motivated to help their weak counterparts. Preliminary exams are conducted for the students appearing for University Exams. Intensive coaching by faculty members is an effective way of bringing concept clarity for students.

**Mentor System:** The College designates a faculty member as mentor for a group of 30-40 students. The mentor meets the students once a month, in a group and interacts with them about their academic and personal difficulties and helps to sort them out. A student can access his/her mentor any time when there is a difficulty.

**Counseling Centre:** Students are counseled by Expert psychologists about their grievances and issues. The discussions are kept confidential. The students are suggested various therapies to handle their difficulties. The institute also has a counseling committee which organizes various activities for spreading awareness on mentalwell-being of students and staff.

**Equal Opportunity Cell:** The Equal Opportunity Cell was established in the year 2022-23 , to aid and advise the students belonging to marginalized sections including the Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Communities (OBCs), minority communities, etc. pursuing various programs of studies at the College.

**Hostel Facility:** The Bombay YMCA established in 1875 and one of the oldest and largest non-profit community service organisations in India has been providing a 'Home away from home' atmosphere for

the male students and working men that are coming from outside the city to embark a journey of learning and secure their wellbeing in Mumbai.

It is located at a very convenient location at C.B.D. Belapur with bus depot and railway station within the reach of 5 minutes and 15 minutes. Apart from conducive atmosphere for studies the students can also avail the facilities of Gym, Basketball, badminton, table tennis and swimming within the premises.

## VARIOUS STATUORY AND NON-STATUORY COMMITTEES

**Students Council:** The Student Council of SIES (Nerul) College of Arts, Science & Commerce aspires to give overall development to the students of the college. Students through their journey of different activities undergo several learning processes which bring in their holistic development, in the areas of personality enhancement, communication skills, leadership, negotiation and other soft skills. Students also develop responsible behaviors not only to themselves but also towards the society.

**THE NATIONAL SERVICE SCHEME (NSS)** : is a Central Sector Scheme of Government of India, Ministry of Youth Affairs & Sports. It provides opportunity to the student youth to take part in various government led community service activities & programmes. NSS is A University of Mumbai affiliated committee. It was established in the year 2000-01 at SIES (Nerul) College of Arts, Science and Commerce. Our College has two NSS Units & the team consists of total 200 enthusiastic volunteers who denote the selfless services and provide hands in delivering community service. Volunteers from Eight different streams (B.Com, BMS, BMM, B.Com(AF), B.Com (BI), B.Com (FM) , B.Sc. IT, B.Sc. CS are involved. NSS Units Conducts Various Activities which includes Tree Plantation, Blood Donation, Rallies & Street Play, Cleanliness Drive (Swatch Bharat Abhiyan), Disaster Management Training, Celebration of Festivals and National / International Days, Health & Safety Awareness Campaigns, 7 days Residential Camp. Students who complete 120 hours of social work are entitled to be awarded 10 grace marks in their first appearance at the examination as laid down under ordinance 229.

**SIESNAA** : SIES Nerul College of Arts, Science and Commerce Alumni ) was established in September 2010. It is the Alumni Association duly registered and recognized by the SIES (NERUL) College of Arts, Science and Commerce. Though it was over a decade since the inception of the College, there was no formal platform for the alumni to interact and give back to the College from where they had gained a lot and more. It was then that the idea of SIESNAA was conceptualized with the main objective to promote / conduct activities and contribute towards the welfare of the alumni, current students and staff of the college.

**Grievance Redressal:** The cell is intended to find solutions for grievances like physical or mental harassment, complaints regarding class room teaching, class room management, completion of syllabus, teaching methodology, infrastructure maintenance and up gradation, etc. if and when they arise.

**Internal Committee:** In pursuance to the UGC/ Supreme Court guidelines, the College has constituted an Internal Committee for gender sensitization and handling complaints against sexual harassment. The committee addresses complaints such as discriminatory behaviour and sexual harassment lodged by any member of the college which he or she observes or become aware of. The committee also advises the authority to take necessary remedial actions including punishment against the offender. The committee consists of representatives from the faculty members, non-teaching staff, students and local community.
